

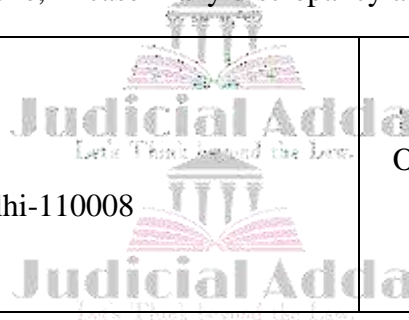

- (1) Preliminary Examination (Objective Type),
- (2) Written Main Examination (Subjective Type),
- (3) Interview.

Bihar APO Prelims Exam Pattern 2024

It is crucial to check the BPSC APO Prelims Exam pattern before start preparing for this exam. The marks gained in the preliminary exam will help to get into the mains exam. Therefore, the prelims exam pattern has been mentioned below -

- This exam will be objective in nature.
- This exam will consist two papers i.e. Paper 1 & 2.
- The exam will be held through offline mode.
- Duration of the exam will be of 2 hours for each paper.
- Each correct question will fetch one mark.
- A negative marking of $\frac{1}{4}$ will also be there.

The BPSC Mains Exam will help a candidate to get into the interview round. This BPSC APO Mains exam pattern has been mentioned below –

- Time duration of 3 hours for each paper will be there.

Topic Wise Bihar APO Prelims Exam Syllabus 2024

The BPSA Prelims exam will include two papers i.e. General Studies and Law papers. What kind of topics these sections will include have been mentioned below. A candidate may check this analysis in order to give a clear direction to his/ her preparation -

1. General Studies -

- General science on everyday life
- General knowledge and current affairs
- Geography Indian history and culture
- Indian political system

2. Law -

- Fundamental knowledge of Indian Constitution
- Indian Penal Code, 1960
- Indian Evidence Act, 1972
- Code of Criminal Procedure, 1972

Topic Wise BPSA APO Mains Exam Pattern 2024

A detailed analysis for BPSA APO sub topics wise detailed syllabus analysis has been provided below -

1. General Studies -

This portion will include questions from below topics -

- Current events of International Importance
- National and General Science
- Geography of India and Bihar
- General Knowledge including Current Affairs
- History of India and salient features of history of Bihar
- Indian Culture
- Major geographical divisions of Bihar and important river system
- Major changes in Bihar's economy during post-independence India
- Indian Political System
- Indian's state system and economics system

2. Hindi Language –

The level of this part is the same that of Hindi Compulsory paper that a student's studies from fourth standard of Bihar Schools Examination Committee's Secondary Examination. This paper is intended to evaluate the general understating of a candidate in Hindi language. The syllabus of the Hindi Language will be as mentioned below –

- Grammar
- Essay Writing
- Syntax

3. **English Language –**

The paper intends to check the general understanding and writing abilities of a candidate in this subject. A passage or passages will usually set for summary or precise. This part of syllabus will cover following topics –

- Essay Writing
- Summary/ Precis Writing
- Letter Writing
- 4. Indian Penal Code, 1860**
- 5. Indian Evidence Act, 1872**
- 6. Code of Criminal Procedure, 1973**
- 7. Other Laws**
 - The Arms Act, 1959
 - Dowry Prohibition Act, 1961
 - The Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Act, 1989
 - Prevention of Corruption Act, 1988
 - Explosive Substances Act, 1908
 - The POCSO Act, 2012

Note – the level of papers from point no.4 to 7 will be equal to that of the Law graduation level of Patna University.

Interview Details for BPSA APO Exam 2024

The interview will be of 100 marks. The marks obtained in this stage will be included in the final merit list. A candidate must secure at least 35% marks in the final merit list.
